The Caucasus Analytical Digest (CAD) (ISSN 1867 9323) is a bi-monthly English-language peer-reviewed internet publication offering expert analyses of the political, economic, and social situation in the three South Caucasus states of Armenia, Azerbaijan and Georgia within the context of international and security dimensions of this region's development. The main audiences in addition to the academic community are policy-makers, business people, journalists and the interested public.

Content and Length

Keeping the needs of its audience in mind, the CAD offers a concise analysis of a specific topic in generally understandable language. An analysis should normally be about 2 000 words long.

The CAD has an applied academic character which should be reflected by clear and factual writing.

Bibliographical references should be made using the Harvard style. Full bibliographical information should be listed in a bibliography at the end of the text.

Please include a brief abstract (one paragraph) and write 1-3 sentences about yourself (e.g. academic title, profession, institutional affiliation) for the "About the Author"-section.

Style

Please use a Word-compatible file format. Apart from tables and graphs there should be no direct technical editing, i.e. no bold or italic words/passages, no page header, no page numbers. Please use the standard newspaper version of names.

Additional data

As an analysis is often followed by a section with related tables and graphs, it would be highly appreciated if you could provide data related to your text (e.g. statistical data, graphical illustrations of organisational structures). Please make sure that you have the copyright for the material submitted. We accept no liability for copyright violations by our authors. The input for tables and graphs should be provided in Excel format, please do not include jpg images.

Submission of the Contributions

The contribution should be submitted at the agreed date to the special editor of the respective issue. The contribution will undergo fast-track peer review. The corresponding editor will inform the special editor whether the publication is either accepted, sent back to you with requests for revisions or rejected. A revised contribution may again be sent to peer review. If accepted, the contribution will be language edited. You will get the edited version of your contribution for final approval.

With the submission of a contribution for publication in the Caucasus Analytical Digest the author grants the institutional editors of the Caucasus Analytical Digest the non-exclusive copyright (including web archiving, secondary exploitation by partners, and any other possible current and future publication formats of the original text).
